
















Figure 9 Crude adult imprisonment rates comparing ACT Indigenous trends to ACT total and Australian total, per 100,000, 1982-2011



Figure 10 Age standardised adult imprisonment rates by Indigenous status in Australia, 2000-2011









Figure 13 Age standardised adult imprisonment rates by Indigenous status in Qld. and Australia, 2000-2011





Figure 14 Age standardised adult imprisonment rates by Indigenous status in Northern Territory and Australia, 2000-2011





Figure 15 Age Standardised Imprisonment Rates by Indigenous Status, per 100,000, Western Australia and Australia, 2000-2011





Figure 16 Age standardised adult imprisonment rates by Indigenous status in South Australia and Australia, 2000-2011





Figure 17 Age standardised adult imprisonment rates by Indigenous status in TAS and Australia, 2000-2011





Figure 19 Imprisonment Rates by Indigenous Status and Gender - Male 1996-2011





Figure 20 Imprisonment Rates by Indigenous Status and Gender - Female 1996-2011


